The Northern Tier Career Center's Joint Operating Committee held a meeting, for general purposes, on August 23, 2016 at 6:30 p.m., in the Conference Room, at the Northern Tier Career Center, Towanda, Pennsylvania.

President Gene Ann Woodruff (Wyalusing) called the meeting to order at 6:30 p.m. followed by the Pledge of Allegiance. The following board members responded to roll call: Evelyn Sherburne (Towanda), Rebecca Ferguson (Sullivan), Howard Rought (NEB), Andrew Hickey (Sayre), Gayle Burkett (Athens), Gene Ann Woodruff (Wyalusing). Also present were Charles Young, Superintendent of Record; Gary Martell, Director; Michele Welles, Business Manager; Margaret Johnson, PN Coordinator; and Colleen Edsell, Board Secretary. PRESENTATION: The JOC reviewed a potential refinancing of the existing Series of 2011 bond issue. The first optional redemption date for the Series of 2011 bonds is March 1, 2017, which allows NTCC to lock in fixed interest rates for the refinancing as early as November 2016, if interest rates provide adequate savings to meet the JOC's approval. The JOC and the participating school districts will each be presented a Resolution at upcoming meetings to authorize the refinancing. In accordance with new procedures of the State Public School Building Authority, the NTCC administration will submit an RFP for bond counsel services. After all Resolutions are approved, the documentation will be submitted to the Department of Community and Economic Development for approval.

A change in the date of Gary Martell's PACTA Summer Symposium was made to be July 27-29, 2016. A motion was made to approve the corrected minutes of the June 23, 2016 regular meeting by Evelyn Sherburne and seconded by Rebecca Ferguson. The motion carried.

REPORTS:

The Practical Nursing Activity Report was provided by Mrs. Margaret Johnson, PN Coordinator. Commencement of 21 students was held on Thursday, August 18, 2016 at Towanda High School. There are currently 29 students enrolled for the next class. There has been a breakfast and lunches hosted for the students as a recruitment process by the Towanda Memorial Skilled Nursing, Bradford County Manor, and also the Green Home in Wellsboro. In addition there was a Career Day hosted on August 5, 2016 for the students. The NCLEX-Prep Course was also hosted for the students in August.
